- 2. Incomplete application or application without supportive evidence asked for, shall be summarily rejected.
- 3. Experience certificate should clearly state the nature of work during the period of employment.
- 4. No-Objection certificate from the current employer/PI if already working in any projects or other agencies.
- 5. All posts are contractual for the duration offered on a short-term engagement on a consolidated salary as detailed against each posts. The appointment is likely to be continued after every specific period of time subject to satisfactory performance of respective P.I of the project and subject to approval of Director to a maximum upto the end of the project.
- 6. Since the appointment of all the posts are under project funded by different agencies, the incumbents selected will have no claim for regular appointments under NIRT/ICMR or continuation of his/her services in the same project of any other project.
