1. The application received after due date will not be considered.
2. The applications will be screened and scrutinized and the eligible candidates will be called for written test.
3. The Written test for the above position will be conducted through in- person at ICAR – SBI Research Centre, Kannur (Scheduled date & time which will be intimated later on through phone/email/ whatsapp or uploaded on institute website (<https://sugarcane@icar.gov.in>)).
4. The candidates should bring a copy of bio-data (specimen enclosed), entire original certificates from SSLC onwards, one set of photocopies of certificates, experience certificate and latest passport size photograph at the time of written test.
5. The candidate should atleast hold a Provisional certificate in r/o. Graduation/Post graduation/Professional courses.(website results/Awaiting for results candidates will not be considered).
6. No objection certificate from the employer, incase he / she is employed else where.
7. No TA/DA will be paid to any candidate to attend the Written test.
8. The above position is purely on temporary basis and is co-terminus with the project.

9. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
10. The selected candidate will be working on whole time basis and will not be allowed to register himself/herself for any academic programme viz. Ph.D. etc.
11. The candidate selected for written test should bring 'RT-PCR' test report (Covid 19 negative) and produce at the time of certificate verification
12. The candidates appearing for the written-test should follow Social Distancing inside the campus till the written test gets completed.
13. The candidates should wear mask till the completion of written test procedure.
14. **The written test will be conducted by strictly following COVID 19 guidelines given by Kerala state government / Government of India.
