Headquarters Hospital Campus, Peiyakulam-625601for engagement of 1 post of Project manager and 1 post of Public Health Specialist, on contract basis for the Public Health Initiative (PHI) project entitled "Promoting the Siddha interventions for iron deficiency anemia (Pandu) among rural women/Men at adolescent age (10 to 19) in South districts Madurai and Theni-Tamil Nadu". The Selected incumbents will be required to work in the PHI project at Madurai and Theni.

The contract will be purely temporary and duration will be for one year. The period of contract is extendable beyond one year based on the performance and with the approval of the Institute.

## Terms and conditions for appointment on contract basis

- 1. The application form can be downloaded from our website https://nischennai.org and the cost of application is Rs.500/-.
- 2. The filled in application along with the application cost of Rs.500/- by way of DD drawn in favour of Director, National Institute of Siddha payable at Chennai together with the self attested photocopies of the certificate/ testimonials should be submitted at the time of walk-in-interview. The candidates should report at 9.30 AM in the Interview venue on 9-6-2022 and the registration will be closed at 11.00 AM. Those who report thereafter will not be considered.
- 3. SC/ST and Physically disabled candidates are exempted from application fee provided that they produce an attested copy of the community certificate and disability certificate respectively from the competent authority along with the application form to claim for application fee exemption.
- 4. Original certificates should be produced at the time of interview.
- 5. Mere fulfilling the minimum prescribed qualification and experience will not vest any right to candidate for engagement.
- 6. The Institute reserves the right to cancel or modify this notification without assigning any reason. The Institute reserves the right not to fill up any or all the posts without assigning any reasons.
- 7. The appointed candidates shall be entitled for 12 days in a calendar year on prorata basis besides Govt. Holidays, thereafter remuneration will be deducted on pro-rata basis. Unavailed leave cannot be encashed or carried forward.
- 8. Theengagement is on whole time basis and the engaged candidate shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract
- 9. The appointment is purely on contract basis. The period of tenure has been indicated against each post. However the appointment can be terminated at any time by The Director, National Institute of Siddha. The appointee shall give atleast one month's notice for discontinuation.
